OWNERS: Joseph & Salome Bowman and Emerson & Rachel Bowman

Description and Key Map of Subject Land: Con 1 Lot 33, Geographic Township of Proton. The lands are further described as 026453 Highway 89.



The Purpose is to sever the parcel into two farm lots. The severed lot would have approximately 205m of frontage on Highway 89 and a lot area of approximately 20ha. The retained parcel would have approximately 205m frontage on Highway 89 and a lot area of approximately 20ha.

The Effect would be to create two farm lots within the Rural designation of the Southgate Official Plan.

Property owners within 60 metres of the subject land are hereby notified of the above application for consent. The property to be severed will be marked by a sign.

If a person or public body has the ability to appeal the decision of the Committee of Adjustment in respect of the proposed consent to the Ontario Land Tribunal but does not make **written submission** to: Committee of Adjustment, Township of Southgate office before it gives a provisional consent, the Tribunal (OLT) may dismiss.
